

Sime Darby Motors (SDM) is an automotive player with operations across the entire value chain of assembly, importation, distribution, retail of new and used cars, after-sales service and rental.

It is primarily a luxury marque player respresenting luxury brands such as BMW, Jaguar, Land Rover, Volvo and Porsche among others as well super-luxury marques including Rolls-Royce, Lamborghini, Ferrari and McLaren.

Sime Darby Motors also represents broad-appeal market brands such as Hyundai, Mazda and Ford, and trucking names such as Fuso, Mack, Hino and Volvo and more recently, electric vehicle brands such as BYD, Nio, Weltmesiter and Li Auto. Sime Darby Motors portfolio also includes vehicle rental business through Hertz, Thrifty and Corefleet.

With an attractive brand portfolio and a strong geographical footprint across ten markets in the Asia Pacific region, Sime Darby Motors prides itself as a partner of choice, having built long standing relationships with some of the world's renowned automotive players.



RETAIL & ASSEMBLY

Retail



Sime Darby Motors' retail operations offer a wide range of vehicles from broad appeal market brands to luxury and super-luxury cars, as well as electric and commercial vehicles. Some of the brands represented by Sime Darby Motors include BMW, MINI, Rolls-Royce, Porsche, Hyundai, Ford, Volvo, Land Rover and BYD. Sime Darby Motors is focused on selling quality products supported by excellent after sales services.

Its retail operations feature some of the best and latest state of the art facilities in the region. Showrooms and service centres throughout the 10 markets are designed to offer customers comfort and experience second to none.

Assembly



Inokom Corporation Sdn Bhd is involved in the assembly of passenger cars, multi utility vehicles, sport utility vehicles, multi-purpose vehicles and light commercial vehicles. Brands assembled include BMW, MINI, Porsche, Mazda, Hyundai and Chery.

In 2018, Sime Darby Motors launched the Sime Darby Auto Engineering (SDAE) Engine Assembly facility. The engine assembly facility supports BMW Group Malaysia's growing demand for locally assembled vehicles with the newest capabilities in engine assembly technology.

Inokom's current capacity is 38,000 vehicles while SDAE's current capacity is 10,000 engines per annum. Both facilities are located in Padang Meha, Kulim, occupying 200 acres of freehold land. Utilising 56% of the site, the two plants have the potential to expand its production facility and is poised to meet increasing demand from the Asia Pacific region.

DISTRIBUTION & IMPORT



Sime Darby Motors serves as a bridge between its principals and customers through its extensive network in the markets it operates in. Its first distribution business began more than 45 years ago through the distribution of BMW vehicles.

It now imports and distributes, among others, BMW, MINI, Rolls-Royce, Ford, Land Rover, Hyundai, Porsche, Suzuki and Mitsubishi passenger vehicles in the Asia Pacific region.

In the commercial vehicle sector, Sime Darby Motors imports and distributes the Volvo Trucks, Hino, UD Trucks, Mitsubishi Fuso, JAC and Mack brands, among others.

Sime Darby Motors acquired BMW Concessionaires (HK) Ltd, the sole importer and distributor of BMW cars and motorcycles in Hong Kong and Macau.

1979

Performance Motors Ltd (PML) gained dealership rights of BMW cars and motorcycles in Singapore.

1981

Tractors Singapore Ltd was appointed sole distributor of Land Rover and Range Rover and franchise holder for Ford in Singapore.

Land Rover Malaysia Sdn Bhd, the sole franchise holder in Malaysia and Brunei was set up by Pernas Sime Darby Holdings and Land Rover Ltd of the UK.

1982

Sime Darby Motors entered the hire and drive business through the setting up of Hertz franchise for Malaysia and Brunei.

1986

1987

Sime Darby Hong Kong Ltd acquired sole distributorship rights for the BMW motor vehicle franchise in Hong Kong and Macau.

Auto Bavaria Sdn Bhd was appointed authorised sole importer and distributor of BMW products in Malaysia.

1991

The first Malaysian assembled BMW 730iL rolled out of the AMI assembly plant, making Auto Bavaria the first BMW importer to assemble the vehicle outside Germany.

1994

Sime Darby Motors acquired distribution rights for the BMW motor vehicle in the Guangdong and Hainan provinces in China.

1998

The after sales parts and services centres for Mitsubishi, Ford, Suzuki and Alfa Romeo were consolidated under Sime Darby Motors Services Ltd.

Sime Darby acquired 80% of Continental Car Services Ltd, a multi- franchise dealership based in Auckland, New Zealand.

1999

The New Discovery was officially rolled out of the Selangor assembly plant, the first Land Rover vehicle to be assembled outside of the UK.

2002

Sime Darby Australia Ltd acquired the Corefleet business.

2003

Sime Darby Hong Kong Ltd renamed as Sime Darby China Ltd and its regional headquarters moved from Hong Kong to Beijing.

Auto Bavaria Sdn Bhd and BMW Group announced the formation of a joint-venture company, BMW Malaysia Sdn Bhd.

2004

Sime Darby Motors acquired distribution rights of Mack, Renault and Hino brands and also added Nissan, Mitsubishi, Kia and Suzuki to the Group's retail business.

2005

Sime Darby Auto Italia Sdn Bhd awarded the exclusive franchise rights of the Alfa Romeo marque in Malaysia.

Sime Darby Motors acquired the Hyundai businesses in Malaysia, adding the Hyundai brand to its marques.

2006

Shanghai Sime Darby Motor Commerce Company Ltd was incorporated in China. The company is primarily involved in the retail of automobiles by Rolls-Royce Motor Cars Ltd.

2009

Sime Darby Hyundai Sdn Bhd acquired the remaining 60% equity interest in Oriental-Hyundai Sdn Bhd, making it a subsidiary of Sime Darby Berhad.

2010

Sime Darby Motors became the retailer of Lamborghini vehicles in China.

Sime Darby Auto Performance Sdn Bhd became the distributor and retailer of Porsche motor vehicles, spare parts, and accessories including provision of related services in Malaysia.

Sime Darby Motors added the Jaguar and Land Rover marques to its retail business in China.

McLaren joined the list of luxury marques distributed by Sime Darby Motors in Hong Kong.

2012

Rolls-Royce's Macau dealership commenced operations Sime Darby Motors Thailand expanded its retail operation for Ford.

2013

Inokom began assembly of Mazda vehicles for export to Thailand.

McLaren began operations in Shanghai and Malaysia.

Sime Darby Motors acquired Brisbane BMW Group in Australia.

Sime Darby Motors entered into JV with Sisma Auto Sdn Bhd, obtaining sole distributorship and dealership of Jaguar and Land Rover vehicles in Malaysia.
